The undersigned is informed and believes that:

COUNT 1

On or about June 3, 2021, in the County of Tulare, the crime of CHILD ABUSE, in violation of PENAL CODE SECTION 273A(a), a FELONY, was committed by EUSTAJIA MOJICA, who did willfully and unlawfully, under circumstances likely to produce great bodily harm and death, injure, cause, and permit a child, J.C., to suffer and to be inflicted with unjustifiable physical pain and mental suffering, and, having the care and custody of said child, injure, cause, and permit the person and health of said child to be injured and did cause and permit said child to be placed in such situation that his/her person and health was/were endangered.

"NOTICE: Pursuant to Penal Code Sections 11166 and 11168, a Suspected Child Abuse Report (SCAR) may have been generated in this case. Penal Code Section 11167 and 11167.5 limit access to a SCAR. A protective order issued by a court is necessary to obtain a copy of the report."

SPECIAL ALLEGATION – WILLFUL HARM OR INJURY RESULTING IN DEATH

It is further alleged pursuant to section 12022.95 that the DEFENDANT, under circumstances and conditions likely to produce great bodily harm and death, willfully caused and permitted a child to suffer, and inflicted thereon unjustifiable physical pain and injury that resulted in death, and having the care and custody of a child, under circumstances likely to produce great bodily harm and death, willfully caused and permitted that child to be injured and harmed and that injury and harm resulted in death.

COUNT 2

On or about June 3, 2021, in the County of Tulare, the crime of INVOLUNTARY MANSLAUGHTER, in violation of PENAL CODE SECTION 192(b), a FELONY, was committed by EUSTAJIA MOJICA, did unlawfully, and without malice, kill J.C., a human being, in the commission of an unlawful act, not amounting to a felony; and in the commission of a lawful act which might have produced death, in an unlawful manner, and without due caution and circumspection.

COUNT 3

On or about June 3, 2021, in the County of Tulare, the crime of CHILD ABUSE, in violation of PENAL CODE SECTION 273A(a), a FELONY, was committed by ARACELI DOMINGUEZ and EMMANUEL ORTIZ-AGUILAR, who did willfully and unlawfully, under circumstances likely to produce great bodily harm and death, injure, cause, and permit a child, E.O., to suffer and to be inflicted with unjustifiable physical pain and mental suffering, and, having the care and custody of said child, injure, cause, and permit the person and health of said child to be injured and did cause and permit said child to be placed in such situation that his/her person and health was/were endangered.

"NOTICE: Pursuant to Penal Code Sections 11166 and 11168, a Suspected Child Abuse Report (SCAR) may have been generated in this case. Penal Code Section 11167 and 11167.5 limit access to a SCAR. A protective order issued by a court is necessary to obtain a copy of the report."

On or about June 3, 2021, in the County of Tulare, the crime of CHILD ABUSE, in violation of PENAL CODE SECTION 273A(a), a FELONY, was committed by ARACELI DOMINGUEZ and EMMANUEL ORTIZ-AGUILAR, who did willfully and unlawfully, under circumstances likely to produce great bodily harm and death, injure, cause, and permit a child, J.O., to suffer and to be inflicted with unjustifiable physical pain and mental suffering, and, having the care and custody of said child, injure, cause, and permit the person and health of said child to be injured and did cause and permit said child to be placed in such situation that his/her person and health was/were endangered.

"NOTICE: Pursuant to Penal Code Sections 11166 and 11168, a Suspected Child Abuse Report (SCAR) may have been generated in this case. Penal Code Section 11167 and 11167.5 limit access to a SCAR. A protective order issued by a court is necessary to obtain a copy of the report."

COUNT 5

On or about June 3, 2021, in the County of Tulare, the crime of CONSPIRACY TO COMMIT A CRIME, in violation of PENAL CODE SECTION 182(a)(1), a FELONY, was committed EUSTAJIA MOJICA, ARACELI DOMINGUEZ, EMMANUEL ORTIZ-AGUILAR, VICTOR MANUEL CORONAFLORES and VALENTIN AGILAR ORTIZ, who did unlawfully conspire together and with another person and persons whose identity is unknown to commit the crime of POSSESSION FOR SALE OF MARIJUANA, in violation of Section 11359, of the HEALTH AND SAFETY Code, a Felony and that pursuant to and for the purpose of carrying out the objects and purposes of the aforesaid conspiracy, the said DEFENDANT committed the following overt act and acts at and in the County of TULARE: 1. CULTIVATED MARIJUANA, 2. HARVESTED AND PROCESSED MARIJUANA, 3. PACKAGED MARIJUANA IN ONE POUND INCREMENTS.

COUNT 6

On or about June 3, 2021, in the County of Tulare, the crime of CRUELTY TO A CHILD BY INFLICTING INJURY, in violation of PENAL CODE SECTION 273A(B), a MISDEMEANOR, was committed by ARACELI DOMINGUEZ and EMMANUEL ORTIZ-AGUILAR, who did willfully and unlawfully, under circumstances and conditions other than those likely to produce great bodily harm and death, having the care and custody of F.A., cause and permit said child to be placed in such situation that his/her person and health were endangered.

"NOTICE: Pursuant to Penal Code Sections 11166 and 11168, a Suspected Child Abuse Report (SCAR) may have been generated in this case. Penal Code Section 11167 and 11167.5 limit access to a SCAR. A protective order issued by a court is necessary to obtain a copy of the report."

COUNT 7

On or about June 3, 2021, in the County of Tulare, the crime of CRUELTY TO A CHILD BY INFLICTING INJURY, in violation of PENAL CODE SECTION 273A(B), a MISDEMEANOR, was committed by ARACELI DOMINGUEZ and EMMANUEL ORTIZ-AGUILAR, who did willfully and unlawfully, under circumstances and conditions other than those likely to produce great bodily harm and death, having the care and custody of R.A., cause and permit said child to be placed in such situation that his/her person and health were endangered.

"NOTICE: Pursuant to Penal Code Sections 11166 and 11168, a Suspected Child Abuse Report (SCAR) may have been generated in this case. Penal Code Section 11167 and 11167.5 limit access to a SCAR. A protective order issued by a court is necessary to obtain a copy of the report."

COUNT 8

On or about June 3, 2021, in the County of Tulare, the crime of CRUELTY TO A CHILD BY INFLICTING INJURY, in violation of PENAL CODE SECTION 273A(B), a MISDEMEANOR, was committed by EUSTAJIA MOJICA, who did willfully and unlawfully, under circumstances and conditions other than those likely to produce great bodily harm and death, having the care and custody of A.C., cause and permit said child to be placed in such situation that his/her person and health were endangered.

"NOTICE: Pursuant to Penal Code Sections 11166 and 11168, a Suspected Child Abuse Report (SCAR) may have been generated in this case. Penal Code Section 11167 and 11167.5 limit access to a SCAR. A protective order issued by a court is necessary to obtain a copy of the report."

COUNT 9

On or about June 3, 2021, in the County of Tulare, the crime of CRUELTY TO A CHILD BY INFLICTING INJURY, in violation of PENAL CODE SECTION 273A(B), a MISDEMEANOR, was committed by EUSTAJIA MOJICA, who did willfully and unlawfully, under circumstances and conditions other than those likely to produce great bodily harm and death, having the care and custody of J.M., cause and permit said child to be placed in such situation that his/her person and health were endangered.

"NOTICE: Pursuant to Penal Code Sections 11166 and 11168, a Suspected Child Abuse Report (SCAR) may have been generated in this case. Penal Code Section 11167 and 11167.5 limit access to a SCAR. A protective order issued by a court is necessary to obtain a copy of the report."

COUNT 10

On or about June 3, 2021, in the County of Tulare, the crime of POSSESSION OR MARIJUANA FOR SALE, in violation of HEALTH & SAFETY CODE SECTION 11359(b), a MISDEMEANOR was committed by EUSTAJIA MOJICA, ARACELI DOMINGUEZ, EMMANUEL ORTIZ-AGUILAR, VICTOR MANUEL CORONAFLORES, and VALENTIN AGILAR ORTIZ, who did, while 18 years of age or over, unlawfully possess marijuana for sale.

"NOTICE: If convicted of this offense the court must suspend your driving privileges if you are under the age of 21 years. Vehicle Code Section 13202.5".

COUNT 11

On or about June 3, 2021, in the County of Tulare, the crime of PLANTING HARVESTING OR PROCESSING, in violation of HEALTH AND SAFETY CODE SECTION 11358(c), a MISDEMEANOR, was committed by EUSTAJIA MOJICA, ARACELI DOMINGUEZ, EMMANUEL ORTIZ-AGUILAR, VICTOR MANUEL CORONAFLORES, and VALENTIN AGILAR ORTIZ, who did unlawfully plant, cultivate, harvest, dry, or process more than six living marijuana plants.

COUNT 12

On or about June 3, 2021, in the County of Tulare, the crime of RESIST, OBSTRUCT, DELAY OF PEACE OFFICER OR EMT, in violation of PENAL CODE SECTION 148(a)(1), a MISDEMEANOR, was committed by VICTOR MANUEL CORONAFLORES, who did willfully and unlawfully resist, delay and obstruct S. ADNEY who was then and there A PEACE OFFICER attempting to and discharging the duty of his/her office and employment.

Pursuant to <u>People v. Cunningham</u>, the People hereby put the defendant on notice that the aggravated sentence may be sought in this case.
