**FELONY COMPLAINT
TWO STRIKES (DABANE HARRELL)**

The undersigned is informed and believes that:

COUNT 1

On or about December 14, 2021, in the County of Tulare, the crime of SECOND DEGREE COMMERCIAL BURGLARY, in violation of PENAL CODE SECTION 459, a Felony, was committed by MIKEY THOMAS MANNING & DEBANE HARRELL, who did enter a commercial building occupied by Best Buy with the intent to commit larceny and any felony.

On or about December 14, 2021, in the County of Tulare, the crime of GRAND THEFT, in violation of PENAL CODE SECTION 487(A), a Felony, was committed by MIKEY THOMAS MANNING & DEBANEE HARRELL, who did unlawfully steal, take, carry, lead, and drive away the personal property of Best Buy, specifically, TABLETS, SPEAKERS, DOORBELL CAMERA AND OTHER ELECTRONICS, which had a value exceeding nine hundred fifty dollars (\$950).

On or about December 14, 2021, in the County of Tulare, the crime of CONSPIRACY TO COMMIT A CRIME, in violation of PENAL CODE SECTION 182(A)(1), a Felony, was committed by MIKEY THOMAS MANNING & DEBANEE HARRELL, who did unlawfully conspire together and with another person and persons whose identity is unknown to commit the crime of GRAND THEFT, in violation of Section 487 of the PENAL Code, a Felony; that pursuant to and for the purpose of carrying out the objectives and purposes of the aforesaid conspiracy, the said defendant(s) MIKEY THOMAS MANNING & DEBANEE HARRELLs committed the following overt act and acts at and in the County of TULARE: TOGETHER WITH CO-CONSPIRATOR, DROVE TO THE BEST BUY STORE IN VISALIA, ENTERED THE STORE, SELECTED MERCHANDISE FROM THE SAME LOCATION IN THE STORE, CARRIED THE MERCHANDISE OUT OF THE STORE WITHOUT PAYING.
