**FELONY COMPLAINT  
First Amended**

The undersigned is informed and believes that:

**COUNT 1**

On or about January 20, 2022, in the County of Tulare, the crime of MURDER, in violation of PENAL CODE SECTION 187(A), a Felony, was committed by ANTHONY LAWRENCE BARRA, who did unlawfully, and with malice aforethought murder CH, a human being.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)."

**SPEC ALLEG-USE OF DEADLY WEAPON**

It is further alleged as to count(s) that in the commission and attempted commission of the above offense, the said defendant(s) ANTHONY LAWRENCE BARRA, personally used a deadly and dangerous weapon(s), to wit, sharp object and wood object, said use not being an element of the above offense, within the meaning of Penal Code Section 12022(b)(1) and causing the above offense to be a serious felony within the meaning of Penal Code section 1192.7(c)(23).

**SPEC ALLEG-FELONY MURDER - BURGLARY**

It is further alleged as to count(s) 1 that the murder of CH was committed by defendant(s) ANTHONY LAWRENCE BARRA while the said defendant(s) ANTHONY LAWRENCE BARRA was/were engaged in the commission of the crime of burglary in the first and second degree in violation of Section 460, within the meaning of Penal Code Section 190.2(a)(17).

**SPEC ALLEG-MURDER WITH TORTURE**

It is further alleged as to count(s) 1 that the murder of CH was committed by defendant(s) ANTHONY LAWRENCE BARRA and that the murder was intentional and involved the infliction of torture, within the meaning of Penal Code Section 190.2(a)(18).

**COUNT 2**

On or about January 20, 2022, in the County of Tulare, the crime of ELDER OR DEPENDENT ADULT ABUSE, RESULTING DEATH, in violation of PENAL CODE SECTION 368(B)(1), a Felony, was committed by ANTHONY LAWRENCE BARRA, who did, under circumstances and conditions likely to produce great bodily harm and death, knowingly and willfully cause and permit the victim, CH, an elder and dependent adult, to suffer, and inflicted thereon, unjustifiable physical pain and mental suffering and, having the care and custody of said victim, willfully caused and permitted her to be placed in a situation in which her health was endangered, and knew and reasonably should have known that said person, CH, was an elder and dependent adult.

It is further alleged, pursuant to section 368(a)(3), that the defendant(s) ANTHONY LAWRENCE BARRA, proximately caused the death of said victim, age 74 years.

On or about January 20, 2022, in the County of Tulare, the crime of TORTURE, in violation of PENAL CODE SECTION 206, a Felony, was committed by ANTHONY LAWRENCE BARRA, who did unlawfully and with the intent to cause cruel and extreme pain and suffering for the purpose of revenge, extortion, persuasion and for a sadistic purpose, inflict great bodily injury, as defined in Penal Code section 12022.7, upon CH.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)."

On or about January 21, 2022, in the County of Tulare, the crime of RESISTING, DELAYING OR OBSTRUCTING A PUBLIC OFFICER, PEACE OFFICER OR EMERGENCY MEDICAL TECHNICIAN, in violation of PENAL CODE SECTION 148(A)(1), a Misdemeanor, was committed by ANTHONY LAWRENCE BARRA, who willfully resisted, delayed, and/or obstructed L.ANDERSON, a peace officer in the discharge or attempted discharge of a duty of his office or employment.

**COUNT 7**

On or about January 21, 2022, in the County of Tulare, the crime of RESISTING, DELAYING OR OBSTRUCTING A PUBLIC OFFICER, PEACE OFFICER OR EMERGENCY MEDICAL TECHNICIAN, in violation of PENAL CODE SECTION 148(A)(1), a Misdemeanor, was committed by ANTHONY LAWRENCE BARRA, who willfully resisted, delayed, and/or obstructed A.BARRAGAN, a peace officer in the discharge or attempted discharge of a duty of his office or employment.

**COUNT 8**

On or about January 21, 2022, in the County of Tulare, the crime of RESISTING, DELAYING OR OBSTRUCTING A PUBLIC OFFICER, PEACE OFFICER OR EMERGENCY MEDICAL TECHNICIAN, in violation of PENAL CODE SECTION 148(A)(1), a Misdemeanor, was committed by ANTHONY LAWRENCE BARRA, who willfully resisted, delayed, and/or obstructed A.FRANCO, a peace officer in the discharge or attempted discharge of a duty of his office or employment.

**COUNT 9**

On or about January 21, 2022, in the County of Tulare, the crime of RESISTING, DELAYING OR OBSTRUCTING A PUBLIC OFFICER, PEACE OFFICER OR EMERGENCY MEDICAL TECHNICIAN, in violation of PENAL CODE SECTION 148(A)(1), a Misdemeanor, was committed by ANTHONY LAWRENCE BARRA, who willfully resisted, delayed, and/or obstructed P.HERNANDEZ, a peace officer in the discharge or attempted discharge of a duty of his office or employment.

**COUNT 10**

On or about January 21, 2022, in the County of Tulare, the crime of PETTY THEFT, in violation of PENAL CODE SECTION 484(A), a Misdemeanor, was committed by ANTHONY LAWRENCE BARRA, who did unlawfully steal, take, carry, lead, and drive away the personal property of Glitz Nail Salon, specifically, electricity, which had a value not exceeding nine hundred fifty dollars (\$950).

**COUNT 11**

On or about January 21, 2022, in the County of Tulare, the crime of BATTERY, in violation of PENAL CODE SECTION 242, a Misdemeanor, was committed by ANTHONY LAWRENCE BARRA, who did willfully and unlawfully use force and violence upon the person of JM.

Pursuant to Penal Code Section 1054.5(b), the People are hereby informally requesting that defense counsel provide discovery to the People as required by Penal Code Section 1054.3.

Pursuant to People v. Cunningham, the People hereby put the defendant on notice that the aggravated sentence may be sought in this case.

I DECLARE UNDER PENALTY OF PERJURY THAT THE FOREGOING IS TRUE AND CORRECT AND THAT THIS COMPLAINT CONSISTS OF 11 COUNT(S).
