The undersigned is informed and believes that:

COUNT 1

On or about February 3, 2022, in the County of Tulare, the crime of WILLFUL, DELIBERATE, AND PREMEDITATED ATTEMPTED MURDER, in violation of PENAL CODE SECTION 664/187(A), a Felony, was committed by ANTONIO SALAS CISNEROS, who did unlawfully and with malice aforethought attempt to murder NA, a human being It is further alleged that the aforesaid attempted murder was committed willfully, deliberately and with premeditation within the meaning of Penal Code section 664(a).

"NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)."

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."

SPEC ALLEG - GBI - DOMESTIC VIOLENCE

It is further alleged, within the meaning of Penal Code section 12022.7(e), as to count(s) one, two, three, and five that in the commission of the above offense, the said defendant(s) ANTONIO SALAS CISNEROS, personally inflicted great bodily injury upon NA, under circumstances involving domestic violence.

"NOTICE: This offense is a serious felony and a violent felony within the meaning of Penal Code sections 1192.7(c)(8) and 667.5(c)(8)."

COUNT 2

On or about February 3, 2022, in the County of Tulare, the crime of ASSAULT WITH A FIREARM-PERSONAL USE OF FIREARM, in violation of PENAL CODE SECTION 245(A)(2), a Felony, was committed by ANTONIO SALAS CISNEROS, who did willfully and unlawfully commit an assault on NA with a firearm.

It is further alleged that, pursuant to Penal Code section 1203.095, there is a presumptive minimal jail time required if you are convicted of this charge.

"NOTICE: This offense is a serious felony and a violent felony within the meaning of Penal Code sections 1192.7(c)(8) and 667.5(c)(8)."

COUNT 3

On or about February 3, 2022, in the County of Tulare, the crime of INJURING A SPOUSE, COHABITANT, FIANCÉ, BOYFRIEND, GIRLFRIEND OR CHILD'S PARENT, in violation of PENAL CODE SECTION 273.5(A), a Felony, was committed by ANTONIO SALAS CISNEROS, who willfully inflicted corporal injury resulting in a traumatic condition upon NA, who was someone with whom the defendant had a dating relationship

SPEC ALLEG-SERIOUS FELONY

It is further alleged, pursuant to Penal Code section 969f, that in the commission and attempted commission of the offense(s) charged in Count(s) one through five, defendant(s) ANTONIO SALAS CISNEROS personally used a firearm, to wit: describe firearmwithin the meaning of Penal Code sections 667 and 1192.7.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."

COUNT 4

On or about February 3, 2022, in the County of Tulare, the crime of CHILD ABUSE UNDER CIRCUMSTANCES OR CONDITIONS LIKELY TO CAUSE GBI OR DEATH, in violation of PENAL CODE SECTION 273A(A), a Felony, was committed by ANTONIO SALAS CISNEROS, who did willfully and unlawfully, under circumstances and conditions likely to produce great bodily harm and death, injure, cause, and permit a child, JS, to suffer and to be inflicted with unjustifiable physical pain and mental suffering, and, having the care and custody of said child, injure, cause, and permit the person and health of said child to be injured and did willfully cause and permit said child to be placed in such situation that his person and health was/were endangered.

SPEC ALLEG-SERIOUS FELONY

It is further alleged, pursuant to Penal Code section 969f, that in the commission and attempted commission of the offense(s) charged in Count(s) one through five, defendant(s) ANTONIO SALAS CISNEROS personally used a firearm, to wit: describe firearmwithin the meaning of Penal Code sections 667 and 1192.7.

COUNT 5

On or about February 3, 2022, in the County of Tulare, the crime of DISCHARGE OF FIREARM WITH GROSS NEGLIGENCE, in violation of PENAL CODE SECTION 246.3(A), a Felony, was committed by ANTONIO SALAS CISNEROS, who did willfully and unlawfully discharge a firearm in a grossly negligent manner which could result in injury and death to a person. <ADL=TX1192.7(C)>

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."

SPEC ALLEG-SERIOUS FELONY

It is further alleged, pursuant to Penal Code section 969f, that in the commission and attempted commission of the offense(s) charged in Count(s) one through five, defendant(s) ANTONIO SALAS CISNEROS personally used a firearm, to wit: describe firearmwithin the meaning of Penal Code sections 667 and 1192.7.
