**FELONY COMPLAINT**

The undersigned is informed and believes that:

**COUNT 1**

On or about May 1, 2022, in the County of Tulare, the crime of ARSON OF A STRUCTURE OR FOREST, in violation of PENAL CODE SECTION 451(C), a Felony, was committed by JESSIE CLARINCE HAGER, JR., who did willfully, unlawfully, and maliciously set fire to and burn and cause to be burned a structure and forest land located at ALEJANDRA'S RESTAURANT (314 W MAIN ST), JIMMY JOHN'S (312 W MAIN ST), DÉCOR TO ADORE (316 W MAIN ST).

**COUNT 2**

On or about May 1, 2022, in the County of Tulare, the crime of ARSON OF PROPERTY OF ANOTHER, in violation of PENAL CODE SECTION 451(D), a Felony, was committed by JESSIE CLARINCE HAGER, JR., who did willfully, unlawfully, and maliciously set fire to and burn and cause to be burned the property of another, to wit, DUMPSTER OWNED BY THE CITY OF VISALIA, located at ALLEY OF 314 W MAIN ST.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."
