The undersigned is informed and believes that:

#### COUNT 1

On or about and between October 1, 2022 and December 15, 2022, in the County of Tulare, the crime of TORTURE, in violation of PENAL CODE SECTION 206, a Felony, was committed by PRISCILLA ROSHELL & MICHAEL CURTIS JR. FRANCIS, who did unlawfully and with the intent to cause cruel and extreme pain and suffering for the purpose of revenge, extortion, persuasion and for a sadistic purpose, inflict great bodily injury, as defined in Penal Code section 12022.7, upon NR.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)."

## COUNT 2

On or about and between October 1, 2022 and December 15, 2022, in the County of Tulare, the crime of TORTURE, in violation of PENAL CODE SECTION 206, a Felony, was committed by PRISCILLA ROSHELL & MICHAEL CURTIS JR. FRANCIS, who did unlawfully and with the intent to cause cruel and extreme pain and suffering for the purpose of revenge, extortion, persuasion and for a sadistic purpose, inflict great bodily injury, as defined in Penal Code section 12022.7, upon NR.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)."

#### COUNT 3

On or about and between October 1, 2022 and December 15, 2022, in the County of Tulare, the crime of CHILD ABUSE UNDER CIRCUMSTANCES OR CONDITIONS LIKELY TO CAUSE GBI OR DEATH, in violation of PENAL CODE SECTION 273A(A), a Felony, was committed by PRISCILLA ROSHELL & MICHAEL CURTIS JR. FRANCIS, who did willfully and unlawfully, under circumstances and conditions likely to produce great bodily harm and death, injure, cause, and permit a child, NR, to suffer and to be inflicted with unjustifiable physical pain and mental suffering, and, having the care and custody of said child, injure, cause, and permit the person and health of said child to be injured and did willfully cause and permit said child to be placed in such situation that their person and health was/were endangered.

## COUNT 4

On or about and between October 1, 2022 and December 15, 2022, in the County of Tulare, the crime of CHILD ABUSE UNDER CIRCUMSTANCES OR CONDITIONS LIKELY TO CAUSE GBI OR DEATH, in violation of PENAL CODE SECTION 273A(A), a Felony, was committed by PRISCILLA ROSHELL & MICHAEL CURTIS JR. FRANCIS, who did willfully and unlawfully, under circumstances and conditions likely to produce great bodily harm and death, injure, cause, and permit a child, NR, to suffer and to be inflicted with unjustifiable physical pain and mental suffering, and, having the care and custody of said child, injure, cause, and permit the person and health of said child to be injured and did willfully cause and permit said child to be placed in such situation that their person and health was/were endangered.
