# **COUNT 1**

On or about and between February 1, 2012 and May 18, 2023, in the County of Tulare, the crime of LEWD ACT UPON A CHILD UNDER AGE 14, in violation of PENAL CODE SECTION 288(A), a Felony, was committed by JEREMY WAYNE HANSON, who did willfully, unlawfully, and lewdly commit a lewd and lascivious act upon and with the body and certain parts and members thereof, to wit, KISSING, FIRST TIME, of G.W, a child under the age of fourteen years, with the intent of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said defendant(s) JEREMY WAYNE HANSON and the said child.

"NOTICE: Conviction of this offense will require to register pursuant to Penal Code section 290 et seq. Willful failure to register is a crime."

"NOTICE: Pursuant to Penal Code Sections 11166 and 11168, a Suspected Child Abuse Report (SCAR) may have been generated in this case. Penal Code Sections 11167 and 11167.5 limit access to a SCAR. A protective order issued by a court is necessary to obtain a copy of the report."

"NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)."

#### **COUNT 7**

On or about May 2, 2023, in the County of Tulare, the crime of CONTACT WITH MINOR FOR SEXUAL OFFENSE, in violation of PENAL CODE SECTION 288.3(A), a Felony, was committed by JEREMY WAYNE HANSON, who did unlawfully contact and communicate with a minor G.W, knowing that G.W was a minor, with the intent to commit an offense specified in Penal Code Section 207, 209, 261, 264.1, 273a, 286, 288, 288.2, 287, 289, 311.1, 311.2, 311.4, and 311.11 involving G.W, to wit: HAND TO BREAST.

"NOTICE: Conviction of this offense will require to register pursuant to Penal Code section 290 et seq. Willful failure to register is a crime."
